In connection with the implementation of the requirements of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46/ EC (general Data Protection Regulation - hereinafter referred to as „GDPR”) I receive information that the data controller of your data is Gravity Park sp. z o. o. based in Warsaw at ul. Goplańska 35, 02-954 Warsaw, tel. 22 299 54 59 registered in the National Court Register in the Register of Entrepreneurs, under No. 0000514593, entered in the REGON register under No. 147296989, with the NIP number 9512380720 (hereinafter referred to as the „Controller”).

Personal data is processed for the purposes of:

1. processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract: article 6.1(b) of the GDPR
2. handling of inquiries related to the submitted statement: article 6.1(f) of the GDPR
3. handling complaints: 1. article 6.1(b) of the GDPR
4. storing documents for the purpose of establishing, investigating or settling claims: article 6.1(f) of the GDPR

Providing data on the consent form is required for booking purposes. Name, surname and date of birth are required for the purposes of person identification and consent.

When providing the details of a child or children, the guardian only provides them for the purpose of identification by the Controller that the child or children have the right to stay on the premises (it is possible based on the age of the child).

The controller does not transfer, sell or lend collected data. Recipients of data may only be authorized employees or associates of the Controller providing services related to handling the process of accepting or filing statements.

Personal data are processed for a period of up to 6 years from the date of submitting the statement. The processing period depends on the possibility of pursuing claims.

Every data subject has the right to right to access personal data, rectify, delete or limit their processing, the right to objection, the right to transfer data, the right to lodge a complaint with a supervisory authority.
